

ORDINANCE 34-C-22

SYNOPSIS: This ordinance, if adopted, would amend Ordinance 25-C-22 (Salary Ordinance) concerning the payment of on call detectives and responsibility differentials.

AN ORDINANCE AMENDING SALARIES OF APPOINTED OFFICERS OF THE CITY OF HUNTINGTON, INDIANA, FROM AND AFTER JANUARY 1, 2023 THROUGH THE PAY PERIOD ENDING DECEMBER 30, 2023; AND HOURLY EMPLOYEES OF THE CITY OF HUNTINGTON, INDIANA, FROM AND AFTER DECEMBER 25, 2022, THROUGH THE PAY PERIOD ENDING DECEMBER 23, 2023

BE IT ORDAINED by the Common Council of the City of Huntington, Indiana, in meeting duly assembled finds that the following portions of Section 1 of Ordinance 25-C-22 should be and hereby are amended as follows:

SECTION 1. That from and after January 1, 2023 through the pay period ending December 30, 2023, the following salary employees of the City of Huntington, Indiana and from and after December 25, 2022 through the pay period ending December 23, 2023, the following hourly employees of the City of Huntington, Indiana, may receive salaries and wages not to exceed the following based on 26 pays for 2023:

Responsibility Differential: Two percent (2%) additional, based on base policeman salary for Resource Officer and Grant Writer. Six percent (6%) additional, based on base policeman salary for Detectives.

REPLACE WITH

Responsibility Differential: Two percent (2%) additional, based on base policeman salary for Resource Officer; Three percent (3%) based on base policeman salary for Grant Writer; Six percent (6%) additional, based on base policeman salary for Detectives.
